

Offer – New Partner Bundles

Activate a subscription to Dext Prepare and benefit from a three-month introductory bundle offer

From 11 October 2021 to 30 November 2021, Dext Software Limited (“**Dext**”) is offering the following discounts on Dext Prepare subscriptions.

(each a “**Promotion**”, and together, the “**Promotions**”), subject to the following terms and conditions.

1. The Promotions are open to any accountancy or bookkeeping practice located in the United Kingdom that does not have an existing subscription plan for Dext Prepare (an “**Eligible Participant**”).

3. The Eligible Participant shall pay the discounted subscription fees for the Promotion Period to Dext on a monthly basis.
