#### 1. INTRODUCTION

- 1.1 EasyProperties is running a lucky draw competition ("BlackBrick Competition") for all persons who have subscribed for a minimum amount of R100 (one hundred Rand), excluding fees and charges, for shares in the Greenpark Lifestyle Estate initial public offering ("IPO") as listed on the EasyProperties Platform during the Competition Period (defined below) in order to stand a chance to win the rental of a fully furnished one bedroom unit at BlackBrick (located at 25 Fredman Drive in Sandton, Johannesburg) ("BlackBrick Unit") or a fully furnished one bedroom unit at the Rockefeller (located at Christiaan Barnard Street in Foreshore, Cape Town) ("Rockefeller Unit") (whichever is applicable) for a period of one year from 6 January 2021 in the case of the BlackBrick Unit or from the date of occupation in the case of the Rockefeller Unit, with no obligation to pay the monthly rental amount (water and electricity amounts are not included and will have to be paid by the winner).
- 1.2 The BlackBrick Competition is subject to the terms and conditions set out below and is subject to and must be read together with the EasyProperties Terms and Conditions.

- 1.4 Capitalised terms used but not defined herein will have the same meaning as in the EasyProperties Terms and Conditions.
- 1.5 By entering the BlackBrick Competition, you agree to be bound by these terms and conditions.

# 2. HOW TO QUALIFY FOR THE BLACKBRICK COMPETITION

- 2.1 In order to be entered into the BlackBrick Competition, you must:
  - (1) be resident in South Africa and a South African citizen;
  - (2) be over the age of 18 years at the time the Prize (defined below) is awarded;
  - have an active EasyProperties account that has been approved for investing in accordance with the EasyProperties Terms and Conditions;
  - (4) have invested a minimum amount of R100 (one hundred Rand), excluding fees and charges, in the Greenpark Lifestyle Estate IPO as listed on the EasyProperties Platform during the Competition Period;

#### TICKETS IN THE DRAW AND WINNER SELECTION 4.

- 4.1 Each person who meets the requirements set out in clause 2.1 above will earn one ticket into the BlackBrick Competition for each R100 (one hundred Rand), excluding fees and charges, subscription amount for shares in the Greenpark Lifestyle Estate IPO listed on the EasyProperties Platform, this also includes money that has already been invested in the Greenpark Lifestyle Estate IPO prior to the start of the Competition Period. For example, if you apply for shares during the Competition Period to the value of R200 (excluding fees and charges), you will receive 2 entries into the BlackBrick Competition or if you had already applied for shares in the amount of R200 (excluding fees and charges) before the Competition Period, you will receive 2 entries into the BlackBrick Competition. If the winner can't take occupation of the BlackBrick Unit in Johannesburg because they are not located in Johannesburg or are unable to relocate to Johannesburg, the winner can request that the fully furnished one bedroom unit be the unit determined by EasyProperties at the Rockefeller located at 12 Christiaan Barnard Street, Foreshore, Cape Town (the Rockefeller Unit).
