NEW PROCEDURE FOR CAMP INSURANCE

As a member benefit of your state coaches association, all members in good standing have a \$1,000,000 per occurrence General Liability policy limit that provides coverage for their coaching activities. In order to protect the General Liability policy from potential claims, the insurance company has mandated that all coaches must obtain signed waivers and provide Participant/Accident insurance for their participants.

In order to obtain a certificate of insurance showing proof of insurance or naming an additional insured, the following must be in place:

- ❖ **Waivers:** Signed waivers showing indemnification language
- ❖ **Participant/Accident Insurance:** You must have Participant/Accident coverage in place for all participants attending sports camps.

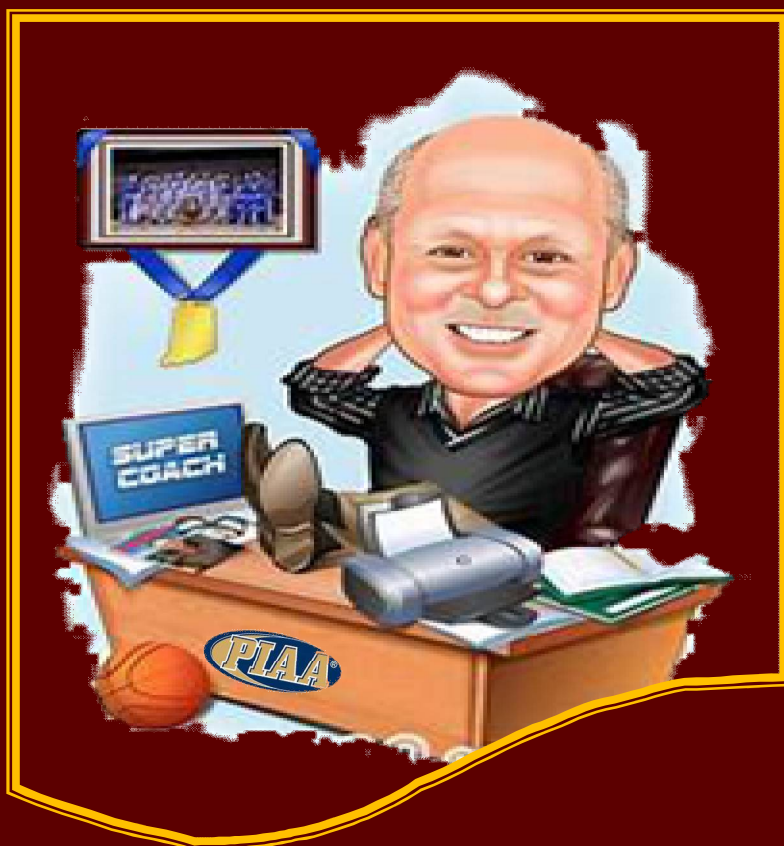

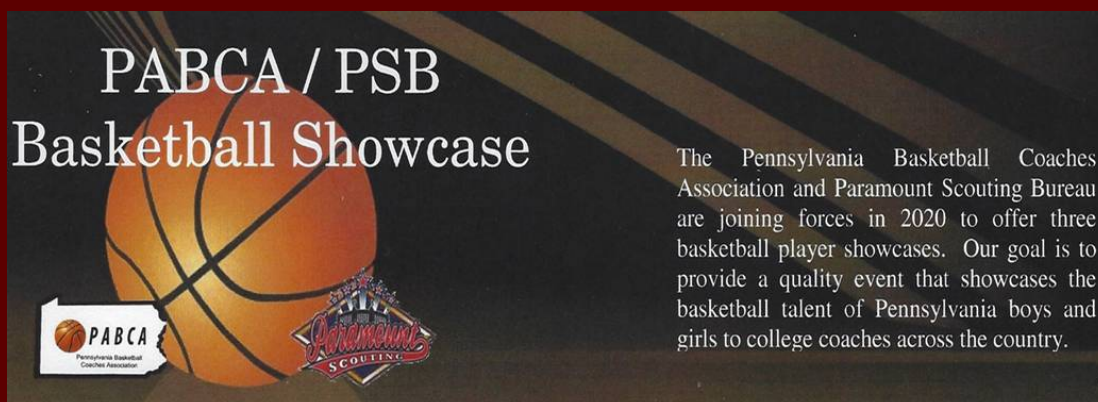

PA Coaches Spotlight ⁸



***Welcome Carolyn and Your PSU Staff for becoming
Members of Pennsylvania Basketball Coaches Association!***

Vice President of Athletics Sandy Barbour announced the selection of ***Carolyn Kieger*** as the sixth head coach of the women's basketball program on April 3, 2019. Kieger, a 2019 Naismith Women's Coach of the Year Award semifinalist, guided Marquette University to the top of the Big East Conference and three consecutive NCAA Tournament appearances as the Golden Eagles' head coach.

Kieger, a 2006 Marquette graduate, comes to Happy Valley after five years at the helm of her alma mater, posting a 99-64 overall record. During the past three seasons, Kieger led the Golden Eagles to sparkling 76-26 mark (43-11 in Big East), which included a pair of Big East regular-season championships and a Big East Tournament Championship. Marquette made three consecutive NCAA Tournament appearances for the first time in 20 years, advancing to the round of 32 the past two seasons. Widely regarded as one of the nation's brightest and rising coaching stars, Kieger's first Marquette team in 2014-15 won nine games. She proceeded to lead the Golden Eagles to 14, 25, 24 and a program-record 27 victories over the next four seasons. Kieger was named a semifinalist for the 2019 Naismith Women's Coach of the Year Award after leading the Golden Eagles to one of the best seasons in program history this past season. Marquette captured its second consecutive, but first-ever outright Big East regular-season title and a posted a school-best 27-8 record. The Golden Eagles were ranked in every Associated Press poll of the season for the first time in school history.

Marquette earned its third-straight NCAA Tournament berth in 2018-19, advancing to the second round for the second consecutive year. The Golden Eagles garnered a No. 5 seed and defeated Rice before dropping a two-point decision at No. 4 seed Texas A&M in the second round. The three consecutive NCAA Tournament appearances were Marquette's first since a three-year run from 1997-99.

Kieger mentored Allazia Blockton and Natisha Hiedeman to become Marquette's first-ever Big East Players of the Year in 2017-18 and 2018-19, respectively. Kieger coached nine All-Big East selections in the last three seasons.

The 2017-18 campaign was another banner year as Kieger was named Big East Co-Coach of the Year after guiding the Golden Eagles to a program-record 15-3 conference mark and their first-ever Big East regular season title. Kieger earned her first NCAA Tournament coaching victory with a first-round win over Dayton before falling at No. 1 seed Louisville.

Kieger coached Marquette to new heights in 2016-17 as the Golden Eagles won the Big East Tournament title for the first time in program history, while also earning a program-best No. 5 seed in the NCAA Tournament. She directed MU to the Big Dance for the first time since 2011. Kieger led Marquette to a 25-8 record in 2016-17, finishing with a 6-0 mark against teams ranked in the Top 25.

In her second year at the helm of the Golden Eagles, Kieger had the youngest program in NCAA Division I with eight freshmen on the roster in 2015-16, as MU improved its win total by five games. She made her collegiate head coaching debut on Nov. 15, 2014 against Green Bay and earned her first career victory on Nov. 17, 2014 when Marquette defeated Loyola-Chicago.

Carolyn Kieger

Prior to being named head coach at her alma mater, Kieger spent six seasons as an assistant coach at the University of Miami from 2008-14. Following graduation, she was at Miami as the coordinator of basketball operations (2006-07) and then served as director of operations at Marquette in 2007-08.

Kieger returned to Miami as an assistant coach in 2008-09 and was primarily responsible for guard development with the Hurricanes. Miami made three NCAA Tournament appearances and two in the WNIT during Kieger's last five seasons with the Hurricanes.

Kieger was a four-year starter at Marquette, a three-year captain and is MU's all-time assists leader. She is the only player in program history with at least 1,200 career points, 400 career rebounds and 600 assists.

During her senior campaign, Kieger was a finalist for the Nancy Lieberman Award, presented to the nation's top point guard. Kieger also received the Big East Conference's Sportsmanship award as a senior.

A native of Roseville, Minnesota, Kieger graduated Cum Laude from Marquette with a bachelor's degree in broadcasting and electronic communications in 2006. She received the McCahill Award in 2007, presented to a graduated MU senior student-athlete who demonstrated the highest performance in scholarship, leadership and athletics.



Steering Committee Meeting Minutes

Thursday, April 20th 2020

MINUTES FOR PIAA BOARD OF DIRECTORS' ACTION

On a motion by Mr. Sette, seconded by Mr. Kinder, it was unanimously voted to recommend to the PIAA Board of Directors, to change the PIAA Basketball Adoption, Rule 5-5 NOTE, running clock, from 40-point differential to a 30-point differential.

The new adoption will read Rule 5-5 NOTE, running clock, at all levels (varsity, junior varsity, or otherwise) of competition, upon completion of the first half, if one team gains a 30-point differential over its opponent, the clock shall be stopped only when an official's timeout is taken, a charged time-out is granted, a period ends, or during administration of free throws.

Motion Passed: Unanimously

ADMINISTRATIVE AND DISCUSSION ITEMS

At its meeting of Thursday, April 30th 2020, the following administrative and other items were discussed by the PIAA Basketball Steering Committee. Steering Committee Meeting Minutes (cont'd)

1. Mrs. Grassel reviewed the 2020 PIAA Boys' and Girls' Basketball Championships and thanked the PIAA District Basketball Chairs' for their assistance and collaboration in acquiring sites and communicating with qualifying schools throughout the PIAA State Tournament. She also thanked them for their cooperation during the unfortunate situation of having to postpone and eventually cancel the 2020 Basketball Championships due to COVID-19.

Mrs. Grassel also informed the committee that it would like to move the 100th year celebration to next year's basketball championship finals. As the tournament had to be cancelled and was unable to be finished, it is important to recognize the 100 years of PIAA basketball championships.

2. Mr. Cardone discussed concerns on the basketball fee schedule that was distributed to all district basketball chairs prior to the tournament. He believed some of the fees were not representative of the work involved for each position. Mr. Byers discussed how these numbers were calculated based on averages of game reports across the commonwealth, and were recommendations to the member schools. Mr. Iacino discussed how District 10 reaches out to schools in advance so the district is aware of fees prior to schools' hosting events.

3. Mr. Cardone inquired about the competition formula and appeals for basketball. Mrs. Grassed discussed the process of the competition formula and informed the committee that letters were emailed to the schools that accumulated enough points and had transfers on April 28th. She informed the committee the process the schools must follow for appealing. The schools that were identified should have their classifications decided after the May Board Meeting on May 20th. Dr. Lombardi added why the competition formula would be implemented even though, unfortunately the basketball championships had to be cancelled. As over half of the tournament was completed, games that were played need to be counted towards the competition formula.
4. Mr. Cardone was interested in the competition formula process moving forward and if there was a possibility of classifications being determined prior to the May Board Meeting so that districts could start scheduling. Mr. Byers informed the committee that it would be difficult to finalize classifications earlier than the May board meeting because of the timing of the process that has to be completed to determine the schools that have triggered the competition formula through success and transfers as well as providing schools with enough time to appeal their competition classification. The time needed to complete this process lends itself to the finalizing of classifications at the May Board Meeting. Mr. Byers added there has been some discussion on moving the May Board Meeting earlier so classifications can be decided.

5. Mr. Anderson updated the committee on the Coaches Association. He provided the committee with information on Basketball Showcases that are planned for the Fall. He also discussed the possibility of adding a shot clock. He informed the committee that he had been contacted by someone who might be interested in funding a shot clock for PA schools. He informed the committee that he had polled some basketball coaches in District 7 about using the shot clock. He is aware that the shot clock is not mandated in the NFHS rule book and understands that it may not be implemented until NFHS makes the change.

Mr. Anderson also informed the committee about the selection of the Basketball Coach of the Years as well as the Boy/Girl Basketball Players of the Year.

6. Mr. Sette discussed the PIAA adoption of the Mercy Rule when a team is winning by 40 points. He discussed that he felt 40 was too much and provided some information on what other states use as mercy rule. Dr. Lombardi provided information on why the rule was changed to 30. Discussion was had by the committee to change the adopted mercy rule to 30 points.
7. Mr. Majikes asked about ticket packets that had been sent to schools as well as game managers and if they needed to be collected. Dr. Lombardi stated that we would like the packets returned when possible. We understand with schools being closed that it may take some time to collect packets.

On a motion by Mr. Bohannon, seconded by Mr. McNamara it was unanimously voted to approve the proposal to change the PIAA Basketball Adoption Rule 5-5 NOTE.; The new adoption will establish a running clock, at all levels (varsity, junior varsity, or otherwise) of competition, upon completion of the first half, if one team gains a 30-point differential over its opponent. If that occurs, the clock shall be stopped only when an official's timeout is taken, a charged time-out is granted, a period ends, or during administration of free throws.

On a motion by Mr. Seltzer, seconded by Ms. Arnold, it was unanimously voted to accept the Minutes of the Basketball Steering Committee.

Mrs. Grassel adjourned the meeting of the PIAA Basketball Steering Committee at 1:53 p.m., Thursday, April 30th, 2020.

Andrew Kettel started his coaching career in 1998 as a volunteer assistant coach for the Scranton Prep Cavaliers freshman team, moving up to the junior varsity and varsity level in 2000. In 2002, Coach Kettel was hired as the head JV coach and guided the Cavaliers for the next four seasons accumulating over 60 wins. He also served as Athletic Director at St. Paul's School.

In July 2007, Coach Kettel was appointed the head boys' basketball coach at Lackawanna Trail High School, where he led the Lions to an overall record of 77-70, guiding them to two Lackawanna League Championship games, winning the trophy in 2010-11 season. That same year, the Trail boys' basketball team was selected as the recipient of the Scranton Chapter of PIAA Basketball Officials' Donald L. Klee Sportsmanship Award.

Between regular seasons, Coach Kettel has successfully coached a variety of age groups in the AAU regional programs at Hoop City & Backcourt Hoops, as well as participating with his teams in numerous summer basketball camps at Villanova University, Saint Joseph's University, The University of Notre Dame and Michigan State University.

Since taking over at Scranton Prep, Coach Kettel has led the Cavaliers to 114 wins and 20 loses, 5 Lynett Tournament Championships ('13, '14,'15,'16),3 Lackawanna League Championships ('15,'16,'17) 4 District II Championships ('15,'16,'17,'18). Kettel has an overall record of 191 wins and 90 loses.

Coach Kettel was selected as one of 50 Positive Coaching Alliance's 2017 Double Goal Coach National Winners presented by TeamSnap. Coach Kettel was also presented with the Walter Venesky Award by the Bochicchio Sports Initiative. NPF Sports named Kettel the 2017 District 2 Big School Coach of the year.

Coach Kettel has served as the chairman of Coaches vs. Cancer of NEPA since 2008. In that short time, his efforts have helped to raise over 1.6 million dollars. In April, Kettel was the first high school coach in the country to receive the Champion Award presented by the American Cancer Society.

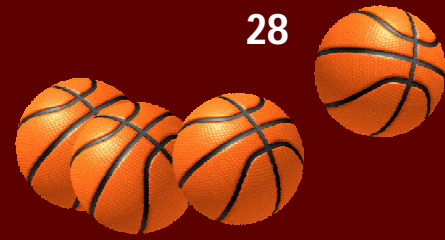

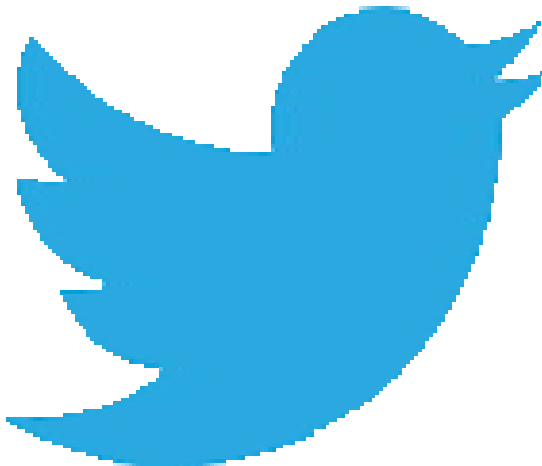
