



**30-0-0 60% Slow Release**  
(Derived from methylated urea)

30-0-0 is a clear liquid fertilizer. This foliar applied fertilizer can be used on row crops, turf, vegetables, and fruit applications. It is a saturated polymer solution. It can be blended with most phosphorous potassium and sulfur sources but only to their solubility thresholds. If this product is being used as a portion of the nitrogen in an NPK blend, it is compatible with most nitrogen sources; it can be mixed with most common pesticides, herbicides, and fungicides. Check compatibility with a jar test before using. This fertilizer should not be mixed with strong acids (i.e. phosphoric) as product degradation will occur and the fertilizer will precipitate.

#### MIXING INSTRUCTIONS

**Fill mix tank with half of the required spray water and begin agitation.**

**Add additional inputs in the following order:**

**Water dispersible granule (WDG), Wettable powders (WP), Dry flowable (DF), Water soluble packets (WSP), Flowables (F & FL), Emulsified concentrate (EC), Solutions (S), Holganix Super Concentrate and 30-0-0, Suspension concentrate (SC), Spray adjuvants \*Agitate fully in between products.**

**Add remaining water.**

**Apply all of the mixture that day.**

**Neutralize highly acidic products to a pH of 7 prior to mixing i.e. phosphoric acid or ammonium sulphate.**

**Can be mixed with potassium and phosphate based products.**
