## Terms and conditions:

- Applicants must be between 7 - 60 years old.
- This plan is available to Thai nationals and foreigners currently residing in Thailand.
- The insured must reside in Thailand for at least 30 consecutive days prior to the policy effective date.
- One person cannot apply for more than one policy with Tune.
- Applicants must be in good health without any disability nor congenital disease.
- Applicants must meet all eligible criteria as specified by the terms and conditions specified by the insurance company.
- The Insurer reserves the right not to accept applications from specific occupation including medical personnel (doctors, nurses, hospital personnel), airport/aircraft personnel (flight attendants, stewards, pilots, airport personnel) and construction workers working on oil rigs or any type of ships.
- The insured must have no records of severe drug allergy to the extent of being hospitalized.
- COVID-19 vaccines must be certified or approved by the Food and Drug Administration of Thailand.
- Customers who are eligible to Health2GO services are Tune Protect Thailand policyholders who have opted for the specific insurance plan with Health2GO service. User is entitled to one session per policy period (in accordance with company policy) and can use the Health2GO service the next day after receiving the policy.
- A waiting period of 14 days applies to this policy.
- Applicants who recently recovered from Covid-19 are eligible to this policy, provided that they have been discharged from the hospital/clinic not less than 30 days before the policy start date.
