The following in a copy of the Confirmation of Understanding of the EarlyON Child and Family Centres Simcoe North enhanced health and safety measures.



<b>Physical distancing:</b> I understand I must maintain a distance of 6 feet or 2 metres from persons not in my family grouping.
<b>Masking:</b> I understand adults must bring and wear a mask to participate in Stay Play and Learn. No masks for children and babies under 2. Older children can but not mandated.
I understand that cloth face coverings should not be placed on:  • Babies or children younger than 2 years old
<ul> <li>Anyone who has trouble breathing or is unconscious; and</li> </ul>
<ul> <li>Anyone who is incapacitated or otherwise unable to remove the mask without help.</li> </ul>
<b>Hand Hygiene:</b> I understand each parent/caregiver/child must complete hand hygiene (unless the child is under 18 months of age) at screening station prior to entering EarlyON Child and Family Centre and regular hand hygiene must be practiced during our visit at the EarlyON Child and Family Centre.
<ul> <li>Self-Screening Assessment I understand that I must complete the COIVD-19 self-assessment for adults and the COVID-19 child screen for children, 1-2 hours before coming to the centre.</li> <li>The screen must be done before coming to the centre</li> </ul>
<b>Temperature:</b> I understand that all adults and child's(ren) temperatures will be checked upon arrival.
<b>Storage:</b> I understand storage of large personal items such as strollers and diaper bags are to be place in a designated area. Please limit items bringing to centre. Simcoe North EarlyON is not responsible for lost or stolen items.
I understand there is no circle time
I understand that there is no <b>FOOD</b> or beverage apart from a refillable water bottle or bottle for infants.
Cancellation if failed Self-Screening Assessment: I understand if a family member answers "YES" to one of the questions on the COIVD-19 self-assessment for adults and the COVID-19 child screen one to two hours before coming to the centre, I will contact the centre to let them know the I will not be attending the session.
<b>Exclusion:</b> I understand if any family member starts showing COIVD-19 symptoms (new, worsening, and not related to other known causes or medical conditions) while at the centre, I will be asked to leave immediately.
<ul> <li>You will be able to attend an EarlyON centre again after answering "NO" to all questions in the COIVD-19 self-assessment for adults and the COVID-19 child screen for children;</li> <li>AND have followed the Simcoe Muskoka District Health Unit recommendations for the new or worsening symptom displayed while at the centre.</li> </ul>
I understand that if they do not adhere to any and all of the preceding guidelines, I will not be permitted to complete my visit at the EarlyON Child and Family Centre and staff will asked them to leave.
