

Avoiding a Penalty

No Cost, No Promoting Interoperability

Quality (85% of Score)

Fully report 6 measures, including 1 outcome measure.

Each measure must:

- Be reported on at least 70% of denominator-eligible patients AND with at least 20 patients in the denominator
- Average at least 5.30 out of 10 points

Improvement Activities (15% of Score)

Perform 1 high-weighted OR 2 medium-weighted activities for 90+ consecutive days.

If group reporting, at least 50% of eligible clinicians must complete the same activity or activities.

Promoting Interoperability (0%)

If you do not have a 2015 certified EHR, apply for the PI hardship reweighting by Dec. 31, 2021.

If you do not receive a hardship, PI will comprise 25% of your MIPS final score.

Scored on Cost, Not on PI

Quality (65% of Score)

Fully report 6 measures, including 1 outcome measure.

Each measure must:

- Be reported on at least 70% of denominator-eligible patients AND with at least 20 patients in the denominator
- Average at least 6.93 out of 10 points*

Improvement Activities (15% of Score)

Perform 1 high-weighted OR 2 medium-weighted activities for 90+ consecutive days.

If group reporting, at least 50% of eligible clinicians must complete the same activity or activities.

Promoting Interoperability (0%)

If you do not have a 2015 certified EHR, apply for the PI hardship reweighting by Dec. 31, 2021.

If you do not receive a hardship, PI will comprise 25% of your MIPS final score.

Cost (20%)

*Cost scores are unpredictable. These steps assume a 0 in Cost to assure penalty avoidance.

No Cost, Scored on PI

Quality (55% of Score)

Fully report 6 measures, including 1 outcome measure.

Each measure must:

- Be reported on at least 70% of denominator-eligible patients AND with at least 20 patients in the denominator
- Average at least 3.82 out of 10 points*

Improvement Activities (15% of Score)

Perform 1 high-weighted OR 2 medium-weighted activities for 90+ consecutive days.

If group reporting, at least 50% of eligible clinicians must complete the same activity or activities.

Promoting Interoperability (30%)

If you do not have a 2015 certified EHR, apply for the PI hardship reweighting by Dec. 31, 2021.

*Quality calculation assumes a score of 80 out of 100 in PI.

Scored on All Categories

Quality (40% of Score)

Fully report 6 measures, including 1 outcome measure.

Each measure must:

- Be reported on at least 70% of denominator-eligible patients AND with at least 20 patients in the denominator
- Average at least 6.25 out of 10 points*

Improvement Activities (15% of Score)

Perform 1 high-weighted OR 2 medium-weighted activities for 90+ consecutive days.

If group reporting, at least 50% of eligible clinicians must complete the same activity or activities.

Promoting Interoperability (25%)

If you do not have a 2015 certified EHR, apply for the PI hardship reweighting by Dec. 31, 2021.

*Quality calculation assumes a score of 80 out of 100 in PI.

Cost (20%)

Cost scores are unpredictable.

*Quality calculation assumes a score of 0 in Cost to assure penalty avoidance.
