WEEDS CONTROLLED

NOTE: Specific weed control recommendations on the Clearcast Herbicide Section 3 label are intended to be a guide for control of those species under certain situations that may require less than maximum labeled rates. Certain circumstances and management objectives may require varying the application method or using a different rate than recommended for a given species, but not to exceed the maximum allowable labeled rate for that site or use.

SMARTWEED SPECIES: Apply Clearcast Herbicide at a concentration of 64 to 128 fluid ounces per acre (0.5 to 1.0 pounds a.i. per acre) or 2.0 to 5.0% v/v, for the control of smartweeds. Control smartweed species with foliar applications using broadcast application equipment, handgun, or backpack application methods. When treating smartweeds, ensure that application method and spray volume provides adequate coverage of targeted plants. Use higher rates to achieve desired control when treating more mature or established plants. Lower concentrations are generally used when conducting early-season, large-scale treatments and when greater selectivity is desired. Applications of Clearcast to emergent, floating or shoreline species require the use of a spray adjuvant. Always use a spray adjuvant that is appropriate for aquatic sites. See the *Spray Adjuvants* section on the product label for specific instructions.
