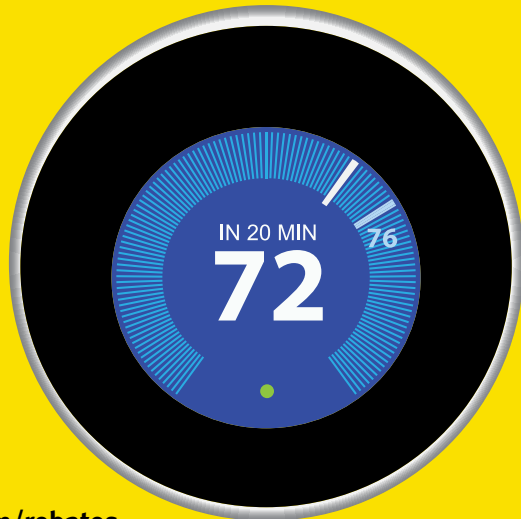

FirstEnergy's Pennsylvania Utilities Rebate Requirements

1. Applicant must be a Pennsylvania residential customer of Met-Ed, Penelec, Penn Power or West Penn Power, FirstEnergy's Pennsylvania utilities.
2. Rebates are available for ENERGY STAR certified smart thermostats purchased in stores or online between June 1, 2021 and May 31, 2026. All rebate applications must be postmarked or submitted online by June 6, 2026.
3. **Rebate applications must be submitted within 90 days of purchase, and be postmarked by June 6, 2026.**
4. Rebate application with valid customer account number must be accompanied by a **legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, store/contractor name, store location, purchase price, and date of purchase.**
5. The rebate is available for new installation or replacement of a manual or conventional programmable thermostat with a ENERGY STAR certified connected thermostat.
6. Please allow up to 30 days from the date all required information is received to process your rebate. **For the fastest rebate possible, submit your rebate application online at energysavePA.com/rebates.**
7. All rebated products must be used at the service (install) address specified on the rebate application.
8. Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
9. FirstEnergy's Pennsylvania utilities and/or their designees including program administrators do not endorse any manufacturer or product as part of this program.
10. Applicants who pay less than the \$50 rebate amount for the ENERGY STAR certified smart thermostat will receive a rebate for the amount paid.
11. By submitting this rebate application, you acknowledge FirstEnergy's Pennsylvania utilities right to audit this application and if requested, you will allow a representative from FirstEnergy's Pennsylvania utilities reasonable access to verify installation of qualifying product(s).
12. By participating in these energy efficiency and peak demand reduction programs, customers agree to allow their utility to retain ownership of all Capacity Rights which refers to the demand reduction associated with any energy efficiency and peak demand reduction measure for which incentives were provided by the Company. Your utility will aggregate these energy efficiency demand reduction attributes into the PJM capacity market with proceeds being used to offset the program costs.
13. **Mail-in rebate not available to customers who purchased product at Lowe's and Home Depot.**
