FirstEnergy's Pennsylvania Utilities Rebate Requirements

- Applicant must be a Pennsylvania residential customer of Met-Ed, Penelec, Penn Power or West Penn Power, FirstEnergy's Pennsylvania utilities.
- Rebates are available for ENERGY STAR certified appliances purchased in stores or online between June 1, 2021 and May 31, 2026.
- Rebate applications must be submitted within 90 days of purchase, and be postmarked or submitted online by June 6, 2026.
- Rebate application with valid customer account number must be accompanied by a legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, store/name, store location, purchase price, and date of purchase.
- Please allow up to 30 days from the date all required information is received to process your rebate. For the fastest rebate possible, submit your rebate application online at energysavePA.com/rebates.
- All rebated products must be used at the service (install) address specified on the rebate application.

- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
