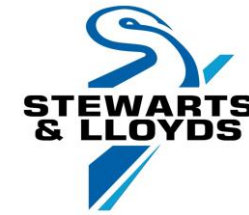

History of Stewarts and Lloyds

- 1898 – Lloyds and Lloyds with branches in Cape Town and Kimberley
- 1903 – Stewarts and Lloyds Founded
- 1939 to mid Eighties – The War Years and Post War Years
- Mid Eighties – Dorbyl acquires Stewarts and Lloyds Group
- Mid Nineties – Robor and Dorbyl JV running Stewarts and Lloyds
- 1988 – Stockwell founded by the current 2 Group Directors
- 2001 - Stockwell acquires Stewarts and Lloyds Company & brand name
- Mar 2013 – Consolidation of 22 companies into 4 companies.
- Product portfolio has grown from the traditional Stewarts & Lloyds offering to include a wide spectrum of steel, tube, fittings, flanges, hardware, irrigation, pipe pumps, valves and added value services



Journey with SYSPRO

Stewarts and Lloyds Companies have been a customer since 1990 through Stewarts and Lloyds Nelspruit with a SYSPRO user count of 28 users

Initially decentralized

- Different SYSPRO Versions and Data Layers countrywide
- Multiple Server at Different Sites with mixed Connectivity

Consolidated all companies to single SYSPRO Environment and Single SYSPRO Company – March 2013

- Consolidated to SYSPRO 6 SQL running in an Offsite Server Room
- Migrated to Data Centre with AdHoc Connectivity Solution

Strategic approach changed to IT – from November 2015 to current

- Upgraded to SYSPRO 7 Update 1
- SDS Technical Services Involvement to assist with implementation of a strategic IT approach
- SDWAN Environment implemented with a Data Centre for Server hosting
- Standardization of IT Equipment and Server Environment
- Separation of Transactional Server from Reporting Server
- Implementation of HPE Simplivity Environment for Server Stability and Performance
- Production, Test, DR and Failover Environments

- Current Database Size is larger than 300GB keeping only 2 Years Data Retention with previous years stored in Archive Companies

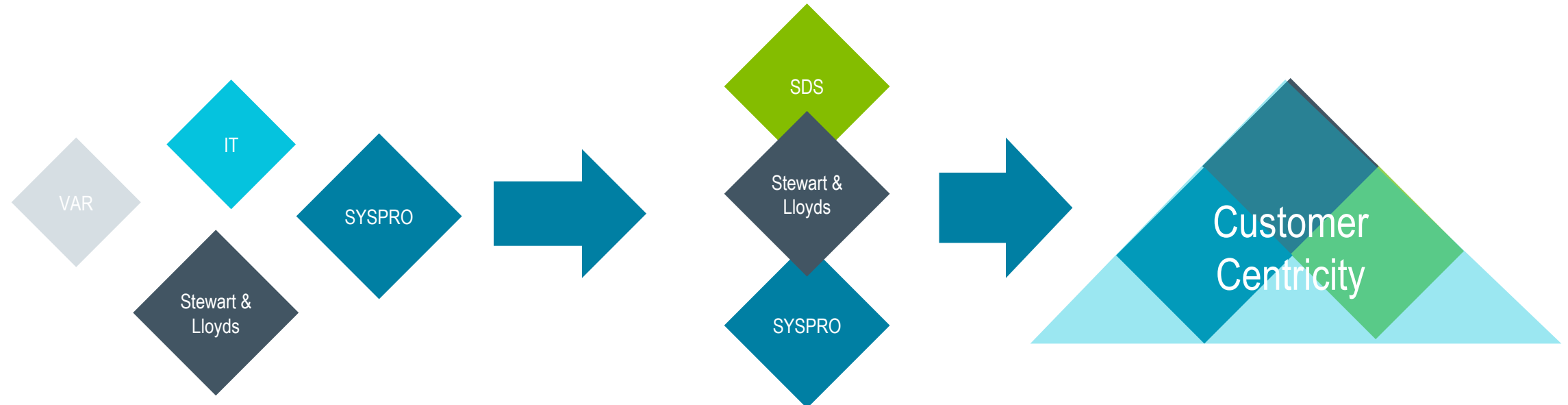
