## LivRite's Mask Policy Effective Immediately at all locations

Please bring and wear a mask. For the health of our members, staff and community, mask use is required for members two and older when within 6' of others, this includes when entering the club and navigating to and from our studios and workout areas.

Mask usage is required except in the following occurrences:

- While exercising and socially distanced
- While participating in outdoor activities and socially distanced
- When not safe or practical, for example:
  - Eating / drinking
  - Swimming
  - Showering
- Medical, Health (physical or psychological), Disability

## FAQ's for the new mask mandate at LivRite:

## Do we need to wear a face covering while playing basketball?

Yes, we will require a face covering for all members who choose to play basketball.

#### Do I need to wear a mask on the cardio equipment?

You do not need a face covering while using cardio equipment. LivRite Fitness has implemented a distance of 6 feet for all cardio.

## Do I need to wear a mask in the free weight area?

Yes, we are requiring masks in the free weight area since it is an area that is harder to maintain social distance.

#### Do I need to wear a mask during a group fitness class?

You do not need to wear a mask if you are able to keep 6' apart during the class. All of our group fitness rooms have been appropriately spaced out. Once class is over, please put covering back on.

#### Do I need to wear a mask when I am on the ramp or during outdoor bootcamp?

You do don't need a face covering while doing outdoor activities such as the ramp and outdoor bootcamp as long as there is 6 feet of social distance.

## Do I need to wear a mask in the pool?

There is no face covering required for swimming but please maintain social distance.

#### Are there exceptions to those who must wear a mask?

Yes, individuals who are unable to wear a mask or face covering for a physical, psychological, medical, or health related reason are exempt. Also, children under two are exempt from wearing a mask.

#### Do I need to wear a mask in the sauna?

No, but gym rules must be followed. There are limits on the number of members in a sauna and social distance must be maintained.

#### Do my children need to wear masks at KidRite?

Yes. Children who are two and older are required to wear a mask upon entry to LivRite and during the duration of their time in KidRite.

## How will Team LivRite enforce the mask policy?

Our philosophy will be rooted in mutual trust and respect for our members. We know the majority of our members will adhere to this guidance as our community wants to keep our fellow members and staff members safe. However, if we see blatant disregard to our policy it will be addressed by a team member.
