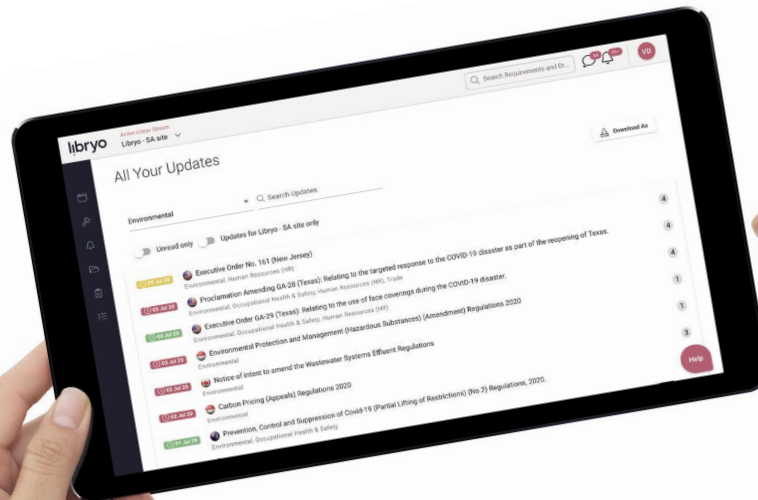

## *How it works*

Comprehensively manage your compliance ecosystem as a single source of truth for your regulatory requirements.

Based on the attributes of each location, Libryo filters the relevant law, enabling you to know your site-specific regulations and compliance status. Data based on your location and context is passed over into the

IsoMetrix platform, and the software continues to check for updates to your regulations.

This data is deployed to the IsoMetrix Compliance Maintenance modules. The integration of this information onto a single platform allows the compliance module to monitor actions and track activities by using one system.

When a regulation changes, Libryo notifies the relevant users both on the platform and via email, presenting the update in a quick summary or the full legislative text. Users are able to mark these updates as read and understood, ensuring everyone that needs to be aware of the change is updated and knows the next steps to take in order to remain compliant.

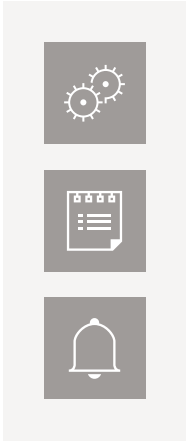
