Privacy Policy

This privacy policy was last updated on 12/04/20.

The Family Rosary, Inc., the parent company of Holy Cross Family Ministries, and its affiliates (collectively referred to as "HCFM," "we," "us" or "our," as applicable) are committed to maintaining the privacy of personal information that you provide to us when using their respective websites (the "HCFM Web Sites"). This Privacy Policy describes how we treat personal information received about you when you visit the HCFM Web Sites.

Information Collected

Web Site Usage Information: We automatically collect IP addresses and web site usage information from you when you visit the HCFM Web Sites.
