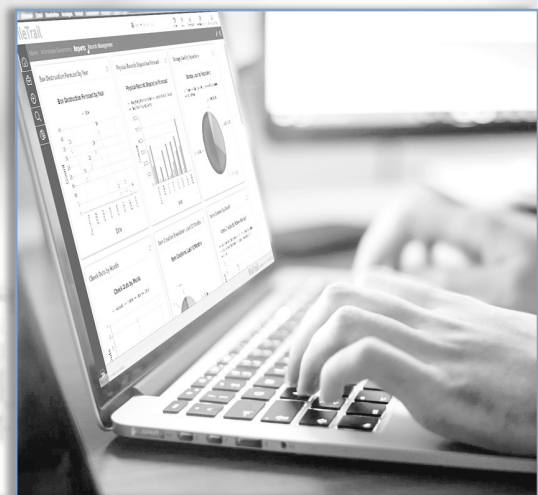
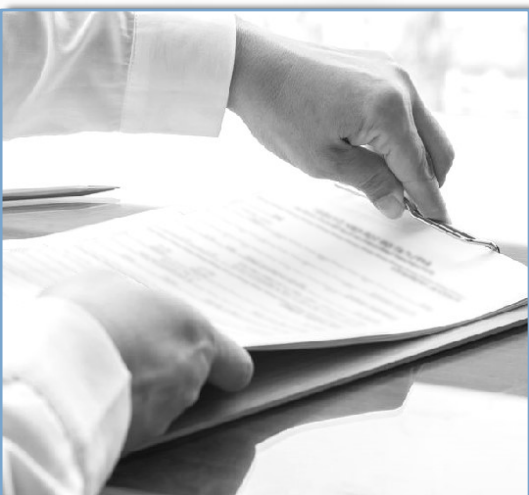

SEARCH AND LOCATE PHYSICAL RECORDS MORE EFFICIENTLY

Looking up and finding the physical records you need should be as easy as finding your electronic documents. And with more staff spending more time working remotely, it saves time to be able to search for the physical records you need without having to send an email or submit queries in person each time.

FileTrail provides fast, accurate information about the status and location of physical records of all types including files, binders and notebooks. Retrieval requests can be submitted via the FileTrail system by authorized users, simplifying the process for both the records center as well as users.



CONTROL ACCESS TO PHYSICAL AND ELECTRONIC DOCUMENTS

Regulatory compliance requires restricting access to documents and other information assets to those who have legitimate need and authority. Automating access management eliminates the need to manually look up permissions for each user, and helps to protect confidentiality and privacy.

FileTrail provides powerful security tools to restrict who may browse a record within a secured area, check a record out of the secured area, or limit what inventories they can see listed in the first place. Additional permissions control user access to view, add, or change descriptive metadata within FileTrail based on department, category, specific record, or field-by-field. FileTrail also makes it straightforward to manage records subject to legal holds, and tag and protect items subject to HIPAA/HITECH, GDPR and other data privacy regulations.



DOCUMENT CHAIN OF CUSTODY

Is your current process for checking records “in” and “out” and documenting chain of custody as efficient as it could be? If your records team has to input the same information in multiple systems, or enter information manually which could be scanned, it’s time to rework your process.

FileTrail provides a flexible and intuitive web-based interface to collect the specific information required for each different type of document, and store that data in a single system. As records are submitted and retrieved, your organization can generate unique item numbers, print and scan labels, and scan the IDs of the person collecting and returning each item. All updates and chain of custody changes are documented with an e-signature process.



STREAMLINE AUDITS AND REPORTING

Many pharmaceutical and biotech companies end up spending a significant amount of staff hours chasing down physical records during FDA audits, as well as audits by other regulatory bodies, partners and customers. Delays in delivering paper documents to FDA audits can result in warnings and penalties, causing firms to incur additional costs as well as delays in getting products to market.

Managing retention schedules via an Excel spreadsheet is no longer sufficient, and other tools still require IT, information governance and records managers to track and find a large volume records manually.

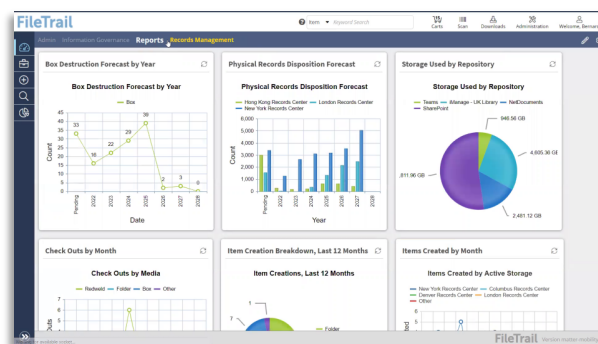
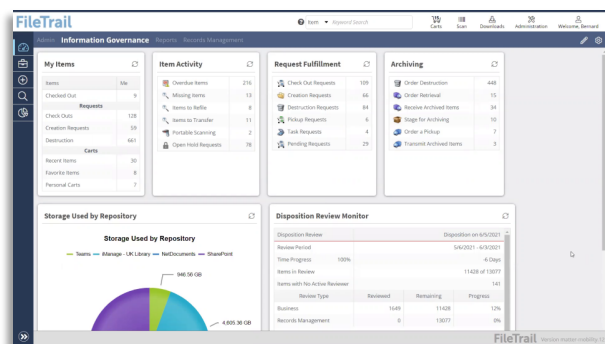
RFID TECHNOLOGY
