

THE SOL GROUP CORPORATION “Pick Your Paradisus 2021” Sweepstakes

Official Sweepstakes Rules and Regulations

NO PURCHASE OR PAYMENT IS NECESSARY. OPEN ONLY TO LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OLDER. VOID WHERE PROHIBITED BY LAW.

By entering THE SOL GROUP CORPORATION “Pick Your Paradisus 2021” Sweepstakes (the "Sweepstakes"), entrants agree to be bound by these Official Sweepstakes Rules and Regulations (the "Official Rules"). The Sweepstakes commences at 9:00am Eastern Daylight Time ("EDT") on March 17, 2021 and ends at 11:59pm EDT on June 1, 2021 (the "Promotion Period"). The Website (defined below) clock is the official timekeeper for this Sweepstakes.

Sponsor. The Sweepstakes is sponsored by THE SOL GROUP CORPORATION ("Sponsor"), 800 Brickell Ave, Suite 601 Miami, FL 33131. The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, Instagram, or any other social media network (as applicable).

Eligibility. The Sweepstakes is open only to legal residents of the 48 Contiguous United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. The Sweepstakes is not open to: (1) employees, independent contractors, officers, and/or directors of Sponsor, and Sponsor’s respective parent, related, affiliated and/or subsidiary companies, advertising, promotion and fulfillment agencies or legal advisors and their respective officers, directors, agents, employees and assigns (collectively, "Released Parties") or (2) the immediate family members of, and persons living in the same household as, any of the Released Parties. “Immediate family” is defined as parents, siblings, children or spouse. How to Enter. During the Promotion Period, visit www.acfaves.com/entertowin (the “Website”) and complete and submit the online registration form. Once you fill out the registration form, in its entirety and submit, you will automatically receive one (1) entry into the Sweepstakes. Each entrant is eligible to submit one (1) entry during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple or different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any entry, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person whom is assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

Prize. The Grand Prize Winner will receive a trip for Two (2) people consisting of the following: Four (4) days/ Three (3) nights hotel accommodations (1 room, double occupancy) at their choice of a Paradisus by Meliá resort location, Two (2) roundtrip coach airline tickets, not to exceed \$500 per person, all meals, drinks, gratuities, taxes related to accommodations, non-motorized water sports and entertainment (each a “Grand Prize”). Vacation must be booked at least twenty-one (21) days prior to arrival at the resort. Subject to availability, blackout dates apply. The Grand Prize is not valid over United States Thanksgiving, Christmas or New Year’s and is subject to availability. Travel must occur between June 1, 2021 and June 1, 2022. Selection of airport, airline, hotel, destination city, and travel dates will be arranged by Sponsor, according to the specifications and limitations in these Official Rules at Sponsor’s sole discretion. Winner's travel companion must be at least eighteen (18) years of age or older as of the date of departure. If

winner's travel companion is under eighteen (18) years of age, the winner must be the travel companion's parent/legal guardian. Travel companion must travel on same itinerary and at the same time as the winner. The winner and guest may be required to provide appropriate government issued photo identification (such as a valid passport) to travel to the host hotel. Sponsor is not liable for any expenses incurred as a consequence of travel cancellation/delay. Due to the current Covid-19 context, Prize Supplier reserves the right to offer an equivalent or superior prize to a contestant.

Approximate retail value of each Grand Prize: \$3,000.00 USD. Actual value may vary based room rate fluctuations. Winner will not receive the difference between actual and ARV.

Grand Prize Winners and their travel companion(s) are responsible for all additional tours, gratuities, fees, discretionary hotel and dining charges, meals in alternative dining venues, alcoholic beverages, boutique purchases and any other incidental costs or other expenses not specifically set forth herein.

If any Grand Prize notification or attempted notification is returned as undeliverable, the Grand Prize will be forfeited and may be awarded to an alternate Grand Prize Winner, time permitting.
