

## **FREE GRINDER GRIP™ GIFT WITH PURCHASE TERMS & CONDITIONS**

### **1. Eligibility:**

A free Grinder Grip™ (the “Promotion”) is available to customers who purchase a “Qualifying WALTER Product,” described in Section 6 below, from an authorized WALTER distributor in the United States (between February 1, 2021 and April 30, 2021) or Canada (February 1, 2021 and March 12, 2021). See the list of authorized distributors in the [United States](#) and [Canada](#). The Promotion is void where prohibited by law. The Promotion is also void in Puerto Rico and all other U.S. Territories and possessions, and is void in overseas military installations. Participants must enter two (2) promo codes and complete the form at **[www.walter.com/grindergrip](http://www.walter.com/grindergrip)** to redeem the gift. The free gift is conditional upon the purchase of multiples of two specially marked products. For example, “buy 2 packs of 06B504 get one Grinder Grip™”, “buy 3 different specially marked products, get one Grinder Grip™”. Promo codes submitted more than once are invalid. Only one gift will be awarded for every submission of two (2) codes. This offer cannot be combined with any other discounts, credits, rebates or other special offers from WALTER. Promo codes will be valid until December 31, 2021 or until quantities last, whichever comes first.

In order to participate in the Promotion, the form on **[www.walter.com/grindergrip](http://www.walter.com/grindergrip)** must be completed accurately and in its entirety. Gift redemptions can be delivered in person by a local WALTER territory or manager (condition applies) or shipped directly to the Company address. Deliveries to the customer’s physical address will not be allowed. Gifts cannot be shipped to post office boxes, reshipping, import/export, individual resellers, procurement or reseller companies, or to distributors. Form submissions are subject to further audit and, at WALTER’s sole discretion, customers may be required to provide additional proof of purchase, including but not limited to physical UPC codes from packaging, product serial numbers or proof of delivery to participate in the Promotion. Customers must redeem the Grinder Grip™ in accordance with Section 4 below.
