THE WORKFORCE CONNECTION CENTERS SERVE MEN AND WOMEN WHO FACE BARRIERS TO EMPLOYMENT. PARTICIPANTS ARE SELF-DIRECTED IN THE SERVICES THAT THEY RECEIVE.
