- Strategic Financial Business Planning Develop a 1, 3, or 5-year business plan generating a monthly P&L, Balance Sheet, Cash Flow and Capital Expenditure forecast/budget. This process involves:
  - A detailed discussion on revenue streams and assumptions driving growth or decline of each revenue stream.
  - A detailed discussion on the cost drivers for each revenue stream and classifying as either variable or fixed costs.
  - Build out of the resources necessary to achieve the plan (Labor, Equipment, Infrastructure).
- 13 Week Cash Flow Forecasts Develop process and template to forecast weekly cash needs. This template includes:
  - Summary file calculating net cash needs on a weekly basis.
  - Input and calculation tabs to forecast materials, COGS, and operating expenses.
- Review monthly financials with business owners and leaders to better understand and analyze the financial results. This will help businesses that may only have a bookkeeper or a small accounting team that only focuses on completing the month-end close but is unable to perform a deep review or analysis of the results.
- Financial Modeling Assess add-on acquisitions, changes in customer base or change to product / market to determine the impact on the business.
- Trusted Advisor Work with entrepreneur / business owner as a sounding board to assess financial results and discuss areas of opportunity. This can range from a few hours a month to one day a week.
- Assist in obtaining conventional debt or outside financing through generation of a complete financial forecast that can be jointly presented to lenders or investors.
- Interim CFO Short term CFO role to bridge a company's need until right person is hired.



- Mergers & Acquisition Project manage the due diligence process for a sale or buy side transaction.
  - Perform financial due diligence to supply required documents to purchaser or vet out acquisition target.
  - Determine proper valuation based on operating performance and applicable add-backs.
  - Coordinate document preparation with legal counsel, including letters of intent and asset purchase agreements.
  - Work with company's tax accountants during preparation of due diligence requirements and legal documents.
  - Actively communicate and work with investment bankers and private equity firms to successfully close a transaction
