

Agency Agreement

relating to the bond issue with ISIN FI4000442264 (the “**Bonds**”)

by and between

B. NORDIC TRUSTEE OY, company reg. no. 2488240-7

1. **Agent’s undertaking:** Nordic Trustee Oy hereby undertakes to act as agent and as applicable, security agent (the “**Agent**”) in accordance with the terms and conditions of the Bonds (the “**Terms and Conditions**”) and the related finance documents insofar as they explicitly refer to the Agent, provided that our assignment as agent under the Terms and Conditions and the related finance documents is conditional upon that the documents to which we will be party is in form and substance satisfactory to us.
2. **Power of Attorney:** The Issuer shall, upon the Agent’s request, promptly issue a power of attorney to the Agent that may be required in order for the Agent to obtain information from the debt register (Fi: *haltijaluettelo*) kept by the relevant central securities depository.
