Requirement 2

You are planning to resume your course within 6 months or your course end date is less than 6 months from the date of completing this form

Requirement 3

You have paid all your tuition fees including the following payment due after the suspension effective date

* Compassionate reasons for course suspension requests are defined as referring to the death of close family, serious and/or chronic psychosomatic or terminal disease and life threatening health condition or medical treatment. Additionally, major political upheaval or natural disaster in the home country requiring emergency travel and traumatic experience such as involvement in or witnessing of a serious accident or crime can be considered as compassionate and compelling reasons. All the above need to be supported by relevant documentation.

* Further medical evidence, such as a report from a specialist, may be requested to support doctor's assessment where conditions including but not limited to mental health and other illnesses have been diagnosed. * Extended suspension (4 months to a maximum of 6 months) may be granted only if sufficient medical evidence is provided.

* No outstanding fees at the time of submission.
