### Bar Admission Checklist

The Georgia bar admissions process is a lengthy, two-step process that requires the submission of two separate applications, each with separate deadlines and fees. Bar applicants must file both an application for **Certification of Fitness to Practice Law in Georgia** and a **bar exam application**. Here's what you need to know and do for Georgia Bar admission:

### ☐ Complete Character and Fitness Application | While In Law School

To become eligible for Admission to the Practice of Law in Georgia, an individual must receive Certification of Fitness by the Georgia Board to Determine Fitness of Bar Applicants. You should complete this while you are still in school to maximize savings. You can also register following graduation in the same manner, paying the applicable fee and providing any required supplemental documents. Once obtained, your Certification of Fitness is good for five years, allowing you to take the bar exam any time after obtaining it.

You will be asked to disclose details about your academic, work, and financial history, as well as any criminal record and civil proceedings. Candor is key. You will also need to include references, your final law school transcripts, driving record, birth certificate, passport and fingerprints.

Your application will be investigated based on the answers you provide, and additional facts discovered in the course of the investigation. Upon completion of the fitness investigation, your Fitness Application will be presented to the Board to Determine Fitness for a determination of your eligibility to practice law.

### Deadlines and associated registration fees:

### Fitness Application filing fees:

- Prior to law school graduation: \$450
- Within one year of law school graduation: \$750

Please note there are different fee schedules for applicants who filed during school but haven't practiced and practicing attorneys.

### ☐ **Create an NCBE Account** | Before Bar Exam Application

All law students are required to create an NCBE Account that comes with a unique NCBE Number for identification purposes. You will need this number to take the MPRE (Multistate Professional Responsibility Exam) and the MBE. (Multistate Bar Exam), which are developed by the NCBE (National Conference of Bar Examiners). The MBE is administered on day two of the Georgia Bar Exam.

### ☐ **Take the MPRE** | Multistate Professional Responsibility Exam

We recommend taking the MPRE any time during 2L year or as early in your 3L year as possible. A scaled score of **75** on the MPRE is required for admission to the Georgia bar. The score must be attained prior to the Issuance of a Certificate for Eligibility for Admission to the Practice of Law. Your passing MPRE score must be submitted to the Georgia Board of Bar Examiners.

The MPRE is a two-hour, 60-question multiple-choice exam developed by the NCBE and administered in the spring, summer, and fall. When registering for the MPRE, students can select one of two dates offered at a time (see chart below) on a first come, first served basis.

### ☐ **Apply for the Bar Examination** | Meeting Filing Deadlines

You can only apply to take the Georgia Bar Exam after obtaining your Certification of Fitness to Practice Law in Georgia. Once you obtain your Certification of Fitness, you will receive an email from the Office of Bar Admissions containing instructions on how to apply for the exam and pay the filing fee. File early to avoid added late fees.

#### Filing deadlines:

#### February (Winter) exam:

- Timely registration: September 1, 2024 January 1, 2025 (until 4 p.m.)
- Final registration: January 1, 2025 January 15, 2025

#### July (Summer) exam:

- Timely: March 1, 2025 June 1, 2025\* (until 4 p.m.)
- Final registration: June 1, 2025 June 15, 2025\*

#### Filing fees (non-refundable):

- Timely: \$498 (\$10 convenience fee if paid by credit card)
- Late registration: \$998
- \*Dates are estimated based on prior years' deadlines; exact dates have not yet been released for the July 2025 exam

### Submit Your Transcripts | Undergrad and Law School

Your undergraduate school and law school must each provide your official transcripts to the Office of Bar Admissions before you can sit for the Georgia Bar Exam. Transcripts must be received via email or regular mail by 4:00 p.m. on the transcript deadlines.

#### Transcript deadlines:

- February (Winter) exam January 31, 2025, 4 p.m.
- July (Summer) exam June 30, 2025, 4 p.m.

Transcripts MUST show the degree awarded and the date conferred. Do NOT request your transcript before you have graduated from law school.

### ☐ **Register Your Laptop** | No Deadline Extensions

You are allowed to use a laptop to type the essay portion of the bar exam by selecting that option on your bar application, paying the fee and then registering your laptop prior to the specified deadlines. Laptop registration typically runs for a month, closing about two weeks before the exam.

### ☐ **Take the Bar Exam** | February 25-26, 2025 / July 29-30, 2025

The Georgia Bar Exam is over two days and requires a passing score of 270 out of a total of 400 points.

#### Exam scores are based on:

- 50% Two Multistate Performance Test (MPT) questions and and four Georgia essays on day one
- 50% 200-question, multiple-choice Multistate Bar Exam (MBE) on day two (morning and afternoon sessions)

MPT testing format: "Closed universe" practical questions using instructions, factual data, cases, statutes, and other reference material supplied by examiners

Essay subjects: Business Organizations, Family Law, Federal Practice and Procedure, Georgia Practice and Procedure, Non-Monetary Remedies, Professional Ethics, Trusts, Wills and Estates, Uniform Commercial Code (Articles 2, 3, & 9), plus all MBE subjects

MBE subjects tested: Constitutional Law, Contracts/Sales, Criminal Law/Procedure, Evidence, Federal Civil Procedure, Real Property, Torts

### Follow Helpful Tips | Guidance You Can Use

Book your hotel room as soon as possible. Rooms for the July bar exam, for example, are typically sold out by September or October of the previous year.

Bring an extension cord in case your laptop charger does not reach the provided outlet.

Lunch options are limited at the Convention Center where the Georgia bar exam is administered. If your school is not providing lunch, plan to find something close by or leave yourself enough time to wait in the lines for something to eat.

Visit the Convention Center on Monday so you're not overwhelmed on Tuesday morning – the first day of the bar exam. This is also a great opportunity to scope out lunch options.
