Attached please find an updated listing of COVID-19 testing sites. The list has been updated to include CVS Pharmacy.

**PLEASE NOTE ALL THESE TESTING SITES ARE FREE**

All private employees to include housekeepers, caregivers, personal trainers, etc., will need to be tested on a two-week cycle with written results provided to Sarasota Bay Club and Jacaranda Trace. We understand that results turnaround time is an issue. From employee experience, we can tell you the quickest turnaround time is Home Depot on Cortez Road and Robert Taylor Community Center on Route 301 in Sarasota. One private employee reports that Robert Taylor Community Center was easy to access early on Sunday morning. University Town Center is the least desirable for wait times and test results.

We ask that your private employee take the test by Friday, August 14<sup>th</sup> and supply us with the results as soon as received. If they do not have the results in hand by the 14<sup>th</sup>, we will take their word they have been tested. They will be allowed to continue to work if they pass screening and supply us results as soon as they are received.

If you wish to have your private employee tested at Sarasota Bay Club or Jacaranda Trace and pay for the test, **please contact Cynthia Deveaux Moona or Gail Chase to schedule an advance appointment**. **Currently tests for private employees are only being done on Mondays and Tuesdays at 11:15 a.m. with advanced appointments only for Sarasota Bay Club. Jacaranda Trace will be coordinated based on demand.** We will need their full name and birthdate. The charge will be put on your monthly service bill.
