If you recently travelled to a hot spot within the 50 states or the District of Columbia, you can end quarantine with a negative result from a test taken after you arrived or no more than 72 hours before you arrived. Use of Masks	Cloth face covering or higher-quality mask if available and tolerated, when not in personal room	
Quarantine Duration	<ul> <li>Quarantine for 14 days, ideally in a separate room, if feasible, from last day of contact/exposure to a case or COVID unit (during the infectious period of the case, whether probable, test-confirmed, or asymptomatic-test confirmed)</li> <li>Quarantine for 14 days after hospital or ED visit discharge if being newly admitted to the facility. Existing residents returning to the facility after an ED visit do not need to quarantine.</li> <li>Hospital discharge to quarantine facility or COVID-negative facility: negative result from one test from a nasopharyngeal specimen during hospital stay (can be during admission)</li> <li>ED discharge to quarantine facility or COVID-negative facility: If no current symptoms of COVID-19, no testing recommended. Monitor and test immediately if symptoms appear.</li> <li>See page 5 for quarantine after COVID-19 infection or vaccination</li> </ul>

Use of Masks	<ul> <li>Cloth face covering, or higher-quality mask, if available and tolerated, when not in personal room</li> <li>Cloth face covering made of at least two layers of tightly woven, breathable fabric</li> <li>Mask fits snugly but comfortably over nose, mouth, and chin without any gaps</li> </ul>
Admission Testing	<ul> <li>DCYF is testing select group home admissions and training school admissions</li> <li>Hospital discharge to congregate care facility: negative test result from a nasopharyngeal specimen during hospital stay (can be during admission)</li> <li>ED discharge to congregate care facility: If no current symptoms of COVID-19, no testing is recommended.</li> </ul>
Quarantine Duration	<ul> <li>10 days from last day of contact/exposure to the case (during the infectious period of the case, whether probable, test-confirmed, or asymptomatic test-confirmed) OR</li> <li>7 days with a negative result from a test taken 5 days or more after exposure</li> <li>Always watch for symptoms for a full 14 days after exposure</li> <li>Ideally quarantine in a separate room, if feasible</li> <li>Quarantine after hospital or ED visit discharge</li> <li>See page 5 for quarantine after COVID-19 infection or vaccination</li> </ul>

Quarantine Guidance for People Within 90 Days of Completed COVID-19 Vaccination or Diagnosis of COVID-19 Infection		
Use of Masks  Definition	<ul> <li>Cloth face covering near people you don't live with, unless higher-quality masks are available and tolerated</li> <li>Cloth face covering at work or medical procedure mask/personal protective equipment (PPE) depending on the type of the work</li> <li>Cloth face covering made of at least two layers of tightly woven, breathable fabric</li> <li>Mask fits snugly but comfortably over nose, mouth, and chin without any gaps</li> <li>Diagnosed with COVID-19 and either:</li> </ul>	
Quarantine After Close Contact* to a Person Suspected or Confirmed to Have COVID-19	<ul> <li>Within 90 days of date of symptom onset OR</li> <li>Within 90 days of date of positive test if asymptomatic</li> <li>Not required if asymptomatic</li> <li>Monitor symptoms for 14 days after exposure</li> <li>Have received all recommended doses of a COVID-19 vaccine</li> <li>Are within 14 to 90 days of receipt of the final dose of COVID-19 vaccine</li> <li>Not required if asymptomatic</li> <li>Monitor symptoms for 14 days after exposure</li> <li>Testing 5 to 10 days after exposure is highly encouraged</li> </ul>	
Quarantine After Travel to a Hot Spot** within the 50 States or District of Columbia (DC) or a Location Outside the 50 States or DC	<ul> <li>Not required if asymptomatic</li> <li>Monitor symptoms for 14 days after exposure</li> <li>Not required if asymptomatic</li> <li>Testing 5 to 10 days after return from travel is highly encouraged</li> </ul>	
Asymptomatic Testing	<ul> <li>Not recommended within 90 days of COVID-19 diagnosis</li> <li>Exempt from work, school, or other asymptomatic surveillance testing</li> <li>Continue to participate in recommended asymptomatic surveillance testing</li> <li>COVID-19 vaccine does not affect COVID-19 test results</li> <li>Testing may identify vaccine-breakthrough cases of COVID-19</li> </ul>	
Population	<ul> <li>Applies to all people</li> <li>Applies to all people except vaccinated hospitalized patients and vaccinated residents in long-term care settings like nursing homes and assisted living facilities</li> <li>Vaccinated hospitalized patients and long-term care facility residents must still quarantine for 14 days after last exposure or out-of-state travel</li> </ul>	
If COVID-19 Symptoms Develop	<ul> <li>Isolate</li> <li>Call your healthcare provider</li> <li>Get a COVID-19 test</li> </ul>	
Testing	To get tested, call your healthcare provider or visit <u>RIDOH's COVID-19 testing</u> <u>webpage</u>	

<sup>\*</sup> Close contact means being within six feet of someone with COVID-19 for a total of 15 minutes or more in a 24-hour period.
\*\* A hot spot is a <u>state with travel restrictions upon entry to Rhode Island</u>.
