- 01 4th Cohort: For early-stage startups (June 7 - July 2, 2021)
- 02 5th Cohort: For later stage startups (September 7 -October 1, 2021)
- 03 4th & 5th Cohorts application deadline: April 12
- 04 Final agreements must be signed and received for both Cohorts by May 10th.

#### **DEFINITIONS**

- 01 Early Stage: The startup has not yet raised a seed round and has a prototype.
- 02 Later Stage: The startup has recently closed a seed round or Series A and has a strong MVP and traction.
- 03 Accepted Solutions: We accept all types of ocean solutions, as long as it's solving our most critical issues as defined by United Nations SDG14. Historically, key impact areas we have considered include aquaculture & fisheries, new materials & packaging and ocean data.

Q Does SOA provide funding?

SOA does invest in select startups post-program and there are opportunities to receive funding from supporters in SOA's network. We will, when relevant, often help make introductions to potential funders. Q Does SOA take equity in startups?

#### A Through SOA, you will be able to leverage our incredible community of mentors, partners, and investors

for the lifetime of your company. We ask for a small amount of equity or the right to invest in a future round in exchange for the time, resources, and valuable support that we provide. If you are building a for-profit business that has a positive impact on ocean health then you should apply to our Accelerator Program. Depending on the stage of your company, you may be accepted into the early stage or later stage program. **Q** If accepted, what documents will be required for completing the offer?

#### A If you are accepted, startups are notified of our intention to send an offer and they are provided with a


