



OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES CHALLENGE.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. **SPONSOR.** The Global MEPs Sweepstakes Challenge (“Sweepstakes Challenge”) is sponsored by Myzone Inc. (“Sponsor”), 311 S Wacker Dr, Suite 480, Chicago, Illinois 60606.
2. **ELIGIBILITY.** The Sweepstakes Challenge is only open to individuals who are aged eighteen (18) years or older on the date of entry (“Eligible Persons”). Employees of Myzone Inc. and its associated companies, as well as members of the immediate family (spouse, parents, siblings and children) and household members of each such employee or anyone else professionally connected with this Sweepstakes Challenge, are not eligible to participate. This Sweepstakes Challenge is not open to residents of Rhode Island and is void where prohibited by local or national laws. It is the responsibility of Eligible Persons to ensure that they are legally eligible to participate and accept the award.
3. **SWEEPSTAKES CHALLENGE PERIOD.** The Sweepstakes Challenge will run from 00:01 on 1 July, 2020 until 23:59 on 31 July 2020 (“Closing Date”, the “Challenge Period”).
4. **CHALLENGE.** During the Challenge Period, one entry voucher (“Voucher”) will be awarded to non-AMOE Registered Entrants, being those that enter pursuant to paragraph 8(A), based on one Voucher for attaining 1,300 MEPs during the challenge period. If participating in the Sweepstakes Challenge via AMOE, one Voucher will be awarded per applicant.
5. **LIMIT.** There is a maximum of one Voucher per Registered Entrant, equivalent to 1,300 MEPs. All MEPs above such number shall be disregarded for the purpose of this or any later Sweepstakes, if any, run by the Sponsor.
6. **AWARD.** Prizes totaling \$10,000 USD and 100 Myzone MZ-3 belts (RRP at \$150 per belt \$15,000) will be awarded as follows:

Cash prizes: 10 x \$500.00 USD = \$5,000

Cash donations, paid directly to chosen charities: 10 x \$500.00 USD = \$5,000

Myzone MZ-3 Belts: 10 belts will be gifted to the facility that each of the winners are associated with. The facility will be determined by reference to the winner’s Facility Code in their app and must be a license-fee paying customer of Myzone.

The winners of the awards will be published on the Myzone website and the awards will be provided by bank transfer to each of the 10 winners and each of the 10 charities. The 10 MZ-3 belts will be mailed to each of the 10 facilities by Myzone. The actual retail value of the award is equivalent to the cash award. The actual retail value of 10 MZ-3 belts to each of 10 facilities is equivalent to \$15,000 USD. The winner shall be liable for any and all taxes incurred as a result of winning or accepting any award, including, without limitation, federal, state, county and local taxes. Sponsor will withhold taxes only as required by law. The winner agrees to indemnify and hold Sponsor and all related parties harmless from all liability for failure to file the required tax returns and failure to pay taxes due with respect to prizes, including penalties and interest.

7. **ODDS.** The odds of winning an award depend on the number of qualifying Registered Entrants during the Challenge Period.

8. **METHOD OF ENTRY.** There are two methods of entry:

(A) Eligible Persons who own a Myzone® fitness belt and are registered as a Myzone user will receive a prompt within the Myzone App to opt into the Sweepstakes Challenge. If they opt out or do not provide an

answer to the prompt, they will not be entered into the challenge. The entrant must confirm they accept the Sweepstakes Challenge terms and conditions.

(B) Eligible Persons who do not own a Myzone® fitness belt, or who are not registered as a Myzone user, may enter the Sweepstakes Challenge through the Alternative Method of Entry described in Paragraph 9.

9. **ALTERNATIVE METHOD OF ENTRY (“AMOE”).** Eligible Persons who do not fall within the provisions of Paragraph 8(A) may enter during the Registration Period by mailing a 3” by 5” card, on which they have typed or legibly hand printed their name, email or mailing address, telephone number, and a statement that he or she wishes to participate in the GLOBAL MEPS SWEEPSTAKES CHALLENGE in a #10 envelope, postage prepaid, to Myzone 311 S Wacker Dr Suite 480, Chicago, IL 60606. No purchase (including purchase or registration of a Myzone® belt) is required to enter via this AMOE. The AMOE must be in a separate outer envelope. No copies or mechanically reproduced entries will be accepted.

Sponsor will send an email (or written confirmation) to each Eligible Person who submits an eligible AMOE, confirming such Eligible Person has been entered into the Sweepstake Challenge. No reply will be sent to non-Eligible Persons or to those with a non-compliant AMOE.

10. **POOL.** The winner will be drawn from the pool of Vouchers, earned during the Challenge Period by the persons entered into the Sweepstakes Challenge pursuant to Paragraphs 8(A) and 9. Such Persons are Registered Entrants. Vouchers for Registered Entrants who are registered pursuant to Paragraph 8(A) are earned via Myzone Effort Points (“MEPs”), associated with the use of their registered Myzone® belt. 11. **REGISTRATION PERIOD.** The Registration Period will begin at 00.01 on 1 July 2020 and end at 23.59 on 31 July 2020. All times shall be based on Central Daylight Time.

12. **WINNER AND NOTIFICATION.** The winner for the Sweepstakes Challenge will be selected via a random process and will be selected within 7 days of the Closing Date. For the purposes of clarity, the winner will be selected by random draw from among the vouchers earned in respect of Eligible Entries received during Challenge Period. The winner will be notified by no later than 7 August 2020 by email.

The winner will be required to respond within 10 days of notification confirming their acceptance of the award and sign and return an Affidavit of Eligibility and Liability/Publicity Release. In the event a winner: i) does not respond to communications within 10 days of notification, ii) declines or does not redeem the award, iii) cannot be verified as eligible, as described below, or iv) fails to provide a signed Affidavit, Sponsor reserves the right to disqualify that winner and present the award to a reserve winner identified using the above process or failing that, present the award to a charity, at its sole discretion. In addition, if the member is not associated with a facility on 31st July the ten belts, nor any alternative prize will be provided.

The winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release.

13. **WINNER.** Registered Entrants may obtain a copy of the results of the random draw by mailing a self-addressed, stamped envelope to Myzone 311 S Wacker Dr Suite 480, Chicago, IL 60606 by 31 July 2020. Such list will be maintained by Sponsor for a period of two years following the Closing Date. Residents of Vermont may omit return postage.

14. **GENERAL.** Entries which do not satisfy the requirements of these Official Rules in full will be disqualified and will be discarded. If it becomes apparent that a participant is using a system or process that is not consistent with the spirit of the challenge that person’s entries will be disqualified and any award will be void.

Sponsor may, at its sole discretion, disqualify entries deemed to be non-compliant with these Official Rules and reserves the right to refuse entry to or disqualify any entrant whose conduct may be unlawful or otherwise bring Sponsor into disrepute. Furthermore, if Sponsor so elects, prize winner may be required to submit to a confidential background check to confirm eligibility and to help ensure that the use of any such person in advertising or publicity will not bring Sponsor into disrepute, and Sponsor may disqualify such winner based on the results of the background check, at Sponsor’s election. In the event of such disqualification Sponsor may present the award to another entrant.

Sponsor reserves the right, at its own discretion and without having to provide any reason for it so doing, to refuse payment to any charity nominated by a winner and in the event that a winner does not nominate a charity

acceptable to the Sponsor the Sponsor shall pay the World Health Organization Covid-19 Solidarity Response Fund.

Sponsor's decision regarding any aspect of the challenge is final and binding and no correspondence will be entered into. This challenge is void where prohibited by law.

15. **LIMITATIONS OF LIABILITY.** Sponsor accepts no responsibility for failing to register Myzone users in the Sweepstakes Challenge or for late, incomplete, incorrectly processed, corrupted or misdirected entries.

If for any reason any aspect of this Sweepstakes Challenge is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any cause beyond our control which corrupts or affects the administration, security, fairness, integrity or proper conduct of this Sweepstakes Challenge, Sponsor may at its sole discretion cancel, terminate, modify or suspend the Sweepstakes Challenge, or invalidate any affected entries.

Sponsor will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Sweepstakes Challenge or accepting of the award, except for any liability which cannot be excluded by law (including personal injury, death and fraud) in which case that liability is limited to the minimum allowable by law.

By participating in this Sweepstakes Challenge, each participant is agreeing to be bound by these Official Rules (and the decision of Sponsor, which shall be final in all respects), and agrees to release Sponsor its directors, officers, employees and agents from, and indemnifying each of them against, any and all liability or any loss, damage or injury of any kind arising from or in connection with this Sweepstakes Challenge. Sponsor reserves the right to withdraw or suspend any Registered Entrant if there is any breach of these Official Rules.

16. **PROMOTION.** The winner shall, upon request, participate in reasonable promotional activity surrounding the winning of the award, for no further consideration, and they consent to the use of their name, likeness, voice, image, and biographical information, anywhere in the world, in any media now existing or hereafter developed, perpetually, in promotional material of Myzone Inc. which may include websites and social media.[Helen: were you wanting the release to capture content they had already added previously through their app? The name and locality of the winner will be displayed on Sponsor's website (www.myzone.org), for which the winner provides their consent.

17. **REMINDER.** Myzone users are reminded that strenuous exercise can be dangerous for persons suffering from many medical conditions. You are urged to consult with a medical professional prior to beginning an exercise routine, including, without limitation, the Sweepstake Challenge.

Myzone personnel are not medically qualified, and do not give medical advice.

A person's entry into the Sweepstakes Challenge constitutes their acknowledgement that they have obtained all medical advice concerning their participation in the Sweepstakes Challenge they deem necessary.

The Myzone® belt must at all times be used in accordance with the Myzone product use and care instructions.

18. **REGISTERED ENTRANT'S PERSONAL INFORMATION.** Information collected from entrants is subject to Sponsor's Privacy Policy, which can be reviewed at <http://www.myzone.org/privacy>. Entrance into this Sweepstakes Challenge constitutes agreement to be bound by these policies.

19. **GOVERNING LAW AND DISPUTES.** Any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes Challenge or any prize awarded shall be resolved individually, without resort

to any form of class action, and exclusively under the laws of Illinois. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this

Sweepstakes Challenge, but in no event attorneys' fees; and under no circumstances will an applicant for entry or Registered Entrant be permitted to obtain awards for, and each hereby waive all rights to claim, indirect, punitive, incidental and consequential damages and any other damages (other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes Challenge, shall be governed by, and construed in accordance with, the laws of the state of Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Illinois.

20. **INTERPRETATION.** It is Sponsor's intention that all provisions of these Official Rules be strictly enforced. In the event that one or more of the provisions set forth in these Official Rules protective of Sponsor are not fully enforceable under applicable Illinois law, such provisions shall be reduced in scope in such limited fashion so as to make such provisions enforceable under applicable Illinois law in such full and complete manner as possible.
