MICROSOFT SOFTWARE LICENSE TERMS MICROSOFT DYNAMICS 365 BUSINESS CENTRAL FOR WINDOWS

IF YOU LIVE IN (OR ARE A BUSINESS WITH A PRINCIPAL PLACE OF BUSINESS IN) THE UNITED STATES, PLEASE READ THE "BINDING ARBITRATION AND CLASS ACTION WAIVER" SECTION BELOW. IT AFFECTS HOW DISPUTES ARE RESOLVED.

These license terms are an agreement between you and Microsoft Corporation (or one of its affiliates). They apply to the software named above and any Microsoft services or software updates (except to the extent such services or updates are accompanied by new or additional terms, in which case those different terms apply prospectively and do not alter your or Microsoft's rights relating to pre-updated software or services). IF YOU COMPLY WITH THESE LICENSE TERMS, YOU HAVE THE RIGHTS BELOW. BY USING THE SOFTWARE, YOU ACCEPT THESE TERMS.

1. INSTALLATION AND USE RIGHTS.

- **a) General.** You may install and run one instance of the software on up to each of ten of your Windows 10 devices that are linked to the Microsoft account associated with your Windows Store account to access and interact with the software to which you have access rights via your Microsoft Dynamics 365 Business Central subscription or your organization's Microsoft Dynamics 365 Business Central subscription and your assigned license.
- **b)** Microsoft Dynamics 365 Business Central Subscription. Use of the software requires a Dynamics 365 Business Central subscription and/or assigned license. Your access to Microsoft Dynamics 365 Business Central through the software must comply with the existing terms for the service that apply to you through your or your organization's subscription.
