# 1. Introducting the ParsePort XBRL Inspector

The ParsePort XBRL Inspector allows you to view, validate and compare XBRL and iXBRL files. If you have access to the ParsePort XBRL Converter, you automatically gain access to the Inspector as well.

In this chapter you will learn what the different functions in the ParsePort XBRL Inspector are, and what you can do with them.




Figure 1: ParsePort XBRL Inspector – Overview

### 1.1 Open Zip Package

Pressing **open zip package** takes you to the upload screen. This is where you load a package into the ParsePort XBRL viewer.

Start by clicking **select a file**, you're computer will then prompt you to select a file zip package from your harddrive. When you have selected a file, click **upload file** to load the file into the Inspector.

#### 1.2 Validation

Clicking on **validation** will take you to the validation report, where you can access the General Information of the report as well as the taxonomy package, get an overview of zip cotent, a validation summary and a validation log.

This is also where you can get an idea of the nature of errors in the report, if any. You will be informed about any errors on creation of the report, as described in the ParsePort XBRL Troubleshooting Guide.

#### 1.3 Viewer

Clicking on **Viewer** will take you to an inline viewer, which will let you see the finalized result of your ESEF report. This gives you the ability to highlight tagged elements as well as inspect each element.

Clicking on **Extensions** will take you to the extensions list. An extensions list is a specification of each individual extension used within the report.

#### 1.6 Presentations

Clicking on **Presentation** will take you to a presentation window, where you can easily access the individual statements and the figures from the annual report.
