Capital Markets Overview

U.S. Equity Market

Equities ended 2019 in a blaze of glory, bolstered by a trade pact between the United States and China. The S&P 500 returned 9.1% during the fourth quarter (31.5% over the trailing 12 months), with growth outperforming value by 3.2%, which is in line with a trend established in the aftermath of the financial crisis. While growth stocks have exhibited an annualized difference totaling 3.6% over value stocks during the last 10 years, it is important that exposures remain balanced in a diversified portfolio. During the quarter, small caps edged out large caps while large caps dominated over the trailing 12 months.

International Equity Markets

International stocks also saw strong returns during the quarter, as emerging markets led the way returning 11.8% with non-US developed market stocks up 8.2%. During 2019, non-US developed markets were up 22.0% compared to emerging markets returning 18.4%. Opposed to the US, developed international small caps outperformed large caps by 3.0% over the trailing 12 months with total returns of 24.9%.

Fixed Income Markets

Fixed-income securities ended 2019 in the black, reversing declines from the year earlier. Spreads on high-yield credit narrowed for the most part of the year, but segments in the high-yield and bank loan market showed signs of stress toward the end of 2019. On a risk-adjusted basis, high-yield and bank loan CCC-bonds posted their worst performance since the financial crisis. US credit ended the year up 13.7%, according to the Barclays Aggregate Index, while the Barclays High Yield Index gained 14.3% in 2019; the Credit Suisse Leveraged Loan Index returned 8.2% during the same period.
