**Complete this form to make a certificate negotiable when the back of the certificate has not been signed.**

**Never** send the signed Stock Power form with the stock certificates. Always send the certificates, via certified mail or overnight deliver, if you prefer, in a separate envelope, with a signed letter of direction stating your gift intentions.

Remember that the signature on the Stock Power must be **exactly** the same as the name on the stock certificate. Then the donor's signature must be guaranteed with a Medallion Signature Guarantee by a commercial bank, trust company or brokerage firm. The completed Irrevocable Stock or Bond Power form should then be mailed to The LCMS Foundation at the above address, using a separate envelope from that used to mail the certificate(s).

One completed Stock Power is required for each corporation whose shares are contributed; multiple certificates for a single company require only one Stock Power for each different registration. Be sure not to write anything on the stock power form other than the number of shares, type of stock, company name, certificate number(s), your signature and the signature guarantee.
