We fulfil our corporate responsibility policy, including our quality policy, through our management system. We establish scorecards, audits and management reviews to ensure that our goals and relevant compliance obligations, as defined in our management systems, are being met.

1.1 Our corporate responsibility commitment

An ethical way of running business is based on three dimensions that are foundational in our operations: social, environmental and financial responsibility.

1.1.1 Social responsibility

- Control critical production features to mitigate risks of recalls due to flawed components
- Replace traditional mechanical measurement tasks by software solutions, which reduces energy and materials usage
