United Robots already serve all local media groups in Sweden and several in Norway and Belgium/Netherlands with automated editorial content. Over the past 6 months the expansion into further markets in Europe and North America has gathered pace, as news publishers increasingly understand the benefits of automation of routine reporting, including freeing up reporter time and expanding hyperlocal coverage. The capital injection from Investment AB Spiltan signals that this trend is only set to accelerate.
