I further acknowledge that Mox.E has put in place preventive measures to reduce the spread of the Coronavirus/COVID-19 but cannot guarantee that I will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to Mox.E staff, members and others.

I voluntarily seek services provided by Mox.E and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19 and that I must comply with all set procedures to reduce the spread while working from the space.

I attest that(*):

- I am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days.
- I have not traveled to a highly impacted area within the United States of America in the last 14 days.
- I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.



- I have not been diagnosed with Coronavirus/Covid-19.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

Mox.E's Responsibilities:

- Face coverings use is mandatory for members, visitors and staff while in the space.
- Printers and scanners will be cleaned after each use. Wipes will be provided in case you want to wipe the device before using it.
- Kitchen:
 - **NOT** available for use:
 - Coffee maker
 - Dishwasher
 - Toaster
 - Snacks will not be replenished.
 - Microwave and refrigerator are available (but must be cleaned after each use)
 - Serve ware, plates, and cups are not available for use.
 - Plasticware and coffee cups are available.
- Regular cleaning of high touch surfaces: kitchen counters, handles, microwave,

refrigerator, chairs among others.

- Clean up and wipe down after each conference room use.
- Pre-screen all members and staff upon arrival for fever equal to or higher than 100.4°F.
- Request that members and staff respect social distancing rules.
- Regularly monitor the space to make sure social distancing rules are being respected.
- Disinfect and clean workspaces multiples times throughout the day.
