Financial Crime Compliance and ESG - The Future of African Investment

On the 30th of July 2021, EBII Group is hosting the Africa IRC Summit, which will bring together key stakeholders within the African investment landscape including, representatives from leading bilateral/multilateral development finance institutions; private equity and impact investments funds; banks and other financial institutions; regulatory authorities and policy makers to share their insights on the prospects of ESG and financial crime compliance in supporting growth and development of the African continent post Covid-19.

First, institutional and private investors will assess how the current economic and health situation on the continent has affected the available investment opportunities, the impact this has on conducting due diligence in Africa and how this is likely to affect investment opportunities in the African continent over the coming years. Second, businesses on the continent would understand what embedding ESG principles entails in practice and the challenges companies

may face in doing so as well as how to mitigate these challenges.

Finally, regulators and policymakers, will gain a deeper understanding of the current money laundering and terrorist financing risks prevalent in the financial system and the impact of covid-19 on these vulnerabilities, this will help Identify areas that a framework could be built to mitigate these challenges.

These discussions complement existing efforts by the EBII Group to provide the knowledge infrastructure needed to address these issues. This includes the Africa Series Executive programme developed in collaboration with the Said Business School, University of Oxford as well as our recently launched Africa Compliance Hub (ACH).
