Sound Credit Union Match & Win Game Official Rules

Promotion Period

Promotion begins on April 5, 2021 at 12:00am and ends on April 30, 2021 at 6:00pm (the "Promotion Period").

Grand Prize Entry

By entering the Promotion, each entrant accepts and agrees to be bound by these Official Rules. No purchase necessary to enter. Limit one entry per person. There are two ways to enter:

- 1: From April 5, 2021 through April 19, 2021, individuals may request to receive a Game Piece by mail (while supplies last), by visiting the promotional microsite at CUinGraham/Win.com. Individual will need to provide their full name, address and valid email address. - 2: Individuals who receive a Sound Credit Union Match & Win direct mailer with a unique prize code ("Game Piece") may take the Game Piece to the Sound Credit Union branch located at 10208 187th Street E., Graham, WA 98374, during the Promotion Period, during regular branch hours, to see if their Game Piece is the Winning Game Piece, as determined by matching the unique prize code on the Game Piece with the winning prize code displayed at the branch.

Grand Prize

If an individual brings in the Winning Game Piece during the Promotion Period, such individual will have the option to choose between a 2021 Mazda CX30 or \$25,000 Cash Prize.
